| <p><b><u>Administrative Seizure Order</u></b><br/><b><u>(ASO - 43/25)</u></b></p> <p><b>Anti-Terrorism Law 5776-2016</b></p> <p>Pursuant to my authority according to section 56(b) of the Anti-Terrorism Law 5776 - 2016 (hereafter - <b>the Law</b>), and having been convinced that the cryptocurrency wallets specified in the below list (hereafter - <b>the Property</b>), are property of the designated terrorist organization <b>Iran's Revolutionary Guards</b><sup>3</sup>, or property used for the perpetration of a severe terror crime as defined by the Law, I hereby order the seizure of the property and of any other virtual asset that is found or will be found in the wallets, as stated, in order to confiscate the same subject to the provisions of section 66 of the Law.</p> <p>Any person who in the course of business or in the performance of his duties was requested to perform an action involving the property, or who received the property to his possession, custody or control, shall report the same to the Israel Police in accordance with sections 33(a) and 34 of the Law and to the National Bureau for Counter Terror Financing (NBCTF) at the Ministry of Defense.</p> <p><b>This order will remain in effect for a period of two years from the date of its signature, or until such time as an order for the forfeiture of the property seized hereby is signed, pursuant to section 66 of the Law.</b></p> | <p><b>أمر حجز إداري (أ.ح. - 43/25)</b><br/><b>قانون مكافحة الإرهاب، لعام 2016</b></p> <p>بموجب الصلاحية الممنوحة لي حسب نص المادة 56 من قانون مكافحة الإرهاب، لعام 2016 (الذي يشار إليه فيما يلي بـ "القانون")، وبعد أن تشكلت لدي قناعة بأن محافظ وعناوين العملات المشفرة المفصلة ضمن القائمة المرفقة بهذا الأمر (التي يشار إليها فيما يلي بـ "الممتلكات") هي ممتلكات خاصة بالمنظمة الإرهابية المعلنة وحرس الثوري الإيراني<sup>2</sup>، أو أنها عبارة عن ممتلكات تم من خلالها ارتكاب مخالفة إرهاب خطيرة حسب تعريفها القانوني، فأبني أصدر أمرًا بالحجز المؤقت للممتلكات ولكل أصل افتراضي يوجد وسيكون موجودًا في حسابات الزبون المذكورة، لأجل مصادرتها رهناً بأحكام المادة 66 من القانون.</p> <p>أي شخص طُلب منه خلال مزاولته أعماله التجارية أو أداء مهامه، إنجاز معاملة ما من خلال الممتلكات المذكورة أو حصل على الممتلكات ليحتفظ بها في حوزته أو ليتصرف فيها، يجب عليه إبلاغ الشرطة الإسرائيلية عن ذلك بموجب أحكام المادتين 33(أ) و34 من القانون وكذلك إبلاغ المقر الوطني للمحاربة الاقتصادية للإرهاب في وزارة الدفاع (NBCTF).</p> <p>سيكون هذا الأمر ساري المفعول لمدة عامين بعد تاريخ توقيعه أو حتى تاريخ توقيع أمر حجز الممتلكات المضبوطة بموجب هذا، حسب المادة 66 من القانون.</p> <p>يحق لأي شخص يدعي حقه في هذه الممتلكات أن يتقدم بما لديه من ادعاءات خطيًا إلى رئيس المقر الوطني لمكافحة الإرهاب الاقتصادي في وزارة الدفاع خلال مدة شهرين بموجب أحكام المادة 61(أ) من القانون. على أن يتم تقديم</p> | <p><b>צו תפיסה מינהלי (צת - 43/25)</b><br/><b>חוק המאבק בטרור, התשע"ו-2016</b></p> <p>בתוקף סמכותי לפי סעיף 56 לחוק המאבק בטרור, התשע"ו-2016 (להלן - <b>החוק</b>), ולאחר שהשתכנעתי כי ארנקי המטבעות הקריפטוגרפים המפורטים ברשימה שלהלן (להלן - <b>הרכוש</b>), הינם רכוש של ארגון הטרור המוכרז <b>משמרות המהפכה של איראן</b><sup>3</sup> או שהם רכוש שנעברה בו עבירת טרור חמורה כהגדרתו בחוק, הנני מורה על תפיסה של הרכוש ושל כל נכס וירטואלי שנמצא ושיימצא בארנקים אמור, לשם חילוטם בכפוף להוראות סעיף 66 לחוק.</p> <p>התבקש אדם לעשות פעולה ברכוש כאמור במהלך עסקיו או במילוי תפקידו, או שהגיע הרכוש לרשותו, לחזקתו או לשליטתו, ידווח על כך למשטרת ישראל בהתאם להוראות סעיפים 33(א) ו-34 לחוק, וכן למטה הלאומי ללוחמה כלכלית בטרור במשרד הביטחון.</p> <p><b>צו זה יעמוד בתוקף לתקופה של שנתיים מיום חתימתו או עד למועד חתימת צו לחילוט הרכוש שנתפס בזה, לפי סעיף 66 לחוק.</b></p> <p>טוען לזכות ברכוש רשאי לטעון את טענותיו ולהגישן בכתב לראש המטה הלאומי ללוחמה כלכלית בטרור במשרד הביטחון בתוך חודשיים, בהתאם להוראות סעיף 61(א) לחוק. השגות יש להגיש באמצעות דוא"ל: <a href="mailto:nbctf@mod.gov.il">nbctf@mod.gov.il</a></p> |
